
Directions

About the Speakers

Virginia H. Adams is a senior architectural historian and project manager at the cultural resource management and historic preservation planning firm, PAL, in Pawtucket, RI. Ginny received her B.A. in Art History and her M.A. in Anthropology, both from Brown University. Her expertise includes architectural history and preservation planning with extensive experience in survey, National Register of Historic Places evaluation and nomination, regulatory compliance, archival documentation, and historical interpretation. Prior to joining PAL in 1987, Ms. Adams worked in the Massachusetts and Rhode Island state historic preservation offices. She currently teaches in the historic preservation program at The Boston Architectural College. She recently led the PAL team for several large Cape Cod Projects. Ginny's family has summered in Barnstable Village since 1964.

Ian Ellison is a local Timberframe (post and beam) expert. He has an engineering degree from McGill Univeristy, has studied timberframe restoration methods in North America and Europe, and has given talks and written on the subject in Canada and the United States. He was even an expert on TV, filmed by the BBC and aired in this country on the Learning Channel. He is a member of the Timber Framer's Guild here in North America and a member of the United Kingdom Carpenters Fellowship. He has inspected and worked on many old buildings around the Cape, including barns, windmills and churches.

David Ottinger has more than 30 years experience working on historic buildings througout New England. He has functioned as a general contractor, sub-contractor, consultant, and designer. He has worked with homeowners, architects, museums, historic commissions, building inspectors, structural engineers and other consultants. His work focuses on preservation of historic buildings, and he sees salvage and demolition as the last resort. He has disassembled and reassembled antique buildings throughout New England, and stabilized, moved and reinstalled architectural and decorative materials. He has extensive experience in documenting buildings and is licensed in Massachusetts as a construction supervisor. He recently completed work on the Atwood Museum, home of the Chatham Historical Society.

Jess Phelps oversees Historic New England's historic preservation efforts, including the Stewardship Program, Historic Homeowner Program, and general advocacy efforts. Prior to joining Historic New England, he worked as an associate attorney at Faegre & Benson, LLP, and clerked for the Honorable Richard W. Goldberg of the U.S. Court of International Trade in New York. Jess has also been involved with conservation and preservation efforts in his native state of Iowa, and has authored several law review articles on topics in this area. Jess holds a B.S. from Iowa State University, and a J.D. from the Drake University Law School, where he served as Editor in Chief of the Drake Law Review.
