About the Speakers

Jeremy Ballard, Vice President of Heritage Restoration Inc., located in Providence, RI and Falmouth, MA, has been in the preservation trades for over 15 years. Jeremy is a graduate of Roger Williams University School of Architecture and Historic Preservation in Bristol, RI, has worked many years in the field, and owned his own preservation carpentry business for 10 years before joining Heritage Restoration, Inc. Jeremy has served on the Falmouth Historic District Commission both as a Commissioner and Chairman, where he helped draft the current Design Review Guidelines. He is a past Director for the Preservation Trades Network, an international non-profit organization that promotes the traditional trades.

John A. Bologna, CEO and President of Coastal Engineering Co., Inc., has a particular interest in early American historic building restoration and preservation. Mr. Bologna has served as an adjunct professor in Construction Technology at Cape Cod Community College, and recently completed a term of service with the BBRS Task Force for Hurricane Resistant Construction. In his consulting engineering practice for historic structures, he has worked for municipal, non-profit, and private residential and commercial clients. He is a member of the Advisory Board of the Home Builders Association and a frequent presenter on engineering design for Construction Supervisor License continuing education training. He holds BS and MS degrees in Engineering from Rice University and is a licenced professional engineer in MA and CT.

Chris Skelly is Director of Local Government Programs at the Massachusetts Historical Commission, where he assists local boards and commissions in community-wide historic preservation planning. He regularly holds regional educational workshops around the state for local commissions, elected officials and the general public. Massachusetts Historical Commission publications prepared by Mr. Skelly include the Preservation Planning Manual, Preservation through Bylaws and Ordinances, A Guidebook for Historic District Commissions, as well as two educational DVDs for local commissions. He is an instructor in the Master of Science in Design and Historic Preservation Program at the University of Massachusetts/Amherst, teaching Cultural Resource Management.

Gregor Trinkaus-Randall received his BA and MA in History and Library Science/Archives Administration from the University of Wisconsin-Madison. He is a member of the Academy of Certified Archivists and former President of the New England Archivists. He served as President of the Society of American Archivists from 2011-2012, and was awarded the ALA/ALCTS George Cunha/Susan Swartzburg Preservation Award in 2012. He is Preservation Specialist at the Massachusetts Board of Library Commissioners and is also a member of the NEDCC's Advisory Committee, the Massachusetts Emergency Management Team, and a member of the Digital Commonwealth's Executive Board, as well as Co-Chair of COSTEP MA and Project Director of *Mitigation for Memory*, a FEMA HMGP grant.
