MODIFICATION TO DEVELOPMENT OF REGIONAL IMPACT DECISION

The Cape Cod Commission approved a Development of Regional Impact (DRI) decision dated February 9, 2006 for a 36,250 square foot, two-story operations center located on Benjamin Franklin Way within Independence Park in Hyannis, MA.

According to condition GC1 in the February 9, 2006 decision, the proposed Cape Cod Co-Operative Bank Operations Center Project shall be constructed in accordance with the following plans: Site Plan prepared by Holmes and McGrath (Sheets 1-5) dated October 18, 2005 and received by staff December 14, 2005. On June 23, 2006 the applicant submitted a letter to Commission staff requesting a minor modification #1 to allow for changes to be made to the site plan for the relocation of a handicap ramp and handicap parking spaces from the rear of the proposed building. At this time, site plans had not been prepared by the applicant showing the proposed changes.

Staff received both a letter from the applicant and revised site plans from Holmes and McGrath (Sheets 1 of 5, 3 of 5 and 5 of 5 dated July 24, 2006) on August 7, 2006, requesting a minor modification #1.

The DRI decision dated February 9, 2006 and amended April 18, 2006 is hereby amended as a minor modification #1 by a determination of the Executive Director on

August 21, 2006. All conditions attached to the original decision dated February 9, 2006 and amended April 18, 2006 continue to apply except as modified herein.

Condition GC1 is replaced with the following:

The proposed Cape Cod Co-Operative Bank Operations Center Project shall be constructed in accordance with the following plans:

- Site Plan prepared by Holmes and McGrath (Sheets 2 of 5 and 4 of 5) dated October 18, 2005 and received by staff December 14, 2005.
- Site Plan prepared by Holmes and McGrath (Sheets 1 of 5, 3 of 5 and 5 of 5) dated July 24, 2006 and received by staff August 7, 2006.
