DECISION OF THE CAPE COD COMMISSION



SUMMARY

The Cape Cod Commission (Commission) hereby approves with conditions the application of Lenord G. Cubellis as a Development of Regional Impact (DRI), pursuant to Sections 12 and 13 of the Cape Cod Commission Act (Act), c. 716 of the Acts of 1989, as amended, for the proposed CanalSide Commons development located at the Bourne Rotary off of Route 28 and Sandwich Road in Bourne, Massachusetts. The decision is rendered pursuant to a vote of the Commission on July 27, 2006.

PROJECT DESCRIPTION

The proposed project consists of the development of a 78,500 s.f. retail complex and a 6,500 s.f. restaurant on an approximately 153-acre site located on Sandwich Road and the Bourne Rotary in Bourne, MA. The applicant proposes to construct the project in two phases of 50,820 s.f. and 34,180 s.f. The project plans also include an approximately 5.3 - acre area to the front of the site and adjacent to the proposed bypass road that has not been designated for any specific use. The applicant proposes to construct a bypass road behind the Bourne Rotary from Route 28 (MacArthur Boulevard) to Sandwich Road to provide access to the site. The proposed project has been revised from an approximately 1,000,000 s.f. mixed-use development previously reviewed jointly as a DRI and under MEPA regulations.

The majority of the site is undeveloped and wooded, with the exception of an area that contains a former motel and former motorbike track, paintball debris, and other unauthorized recreational activities. The Upper Cape Regional Vocational Technical High School is adjacent to and north of the site. The Massachusetts Military Reservation (MMR) forms the eastern boundary of the project site and the Bourne landfill is approximately 3/4-mile south of the project site. The site is currently zoned B2 and B3 Business. The proposed project would require a special permit from the Bourne Planning Board.

During prior joint DRI/MEPA review, the project site increased to approximately 183 acres with the addition of an approximately 5-acre former motel site immediately west of the original project site, and 25 acres of land immediately south of the original CanalSide property. The applicant has demonstrated through the submission of affidavits that this additional 30 acres of land is no longer under the applicant's control and therefore the project site totals 153 acres.

JURISDICTION

The original joint DRI application/ENF qualifies as a DRI pursuant to Sections 12(i) and 13(b) of the Act as "any proposed development for which the Secretary of Environmental Affairs requires the preparation of an Environmental Impact Report in accordance with the provisions of Sections 61-62H, inclusive, of Chapter 30 of the General Laws shall be deemed a Development of Regional Impact".

PROCEDURAL HISTORY

The applicant submitted an ENF to the Executive Office of Environmental Affairs (EOEA), MEPA Unit on July 15, 1998. Since, pursuant to MEPA, the project was categorically required to prepare an Environmental Impact Report (EIR), it was also deemed a mandatory DRI pursuant to the Act. Accordingly, the applicant agreed to proceed with a joint DRI/MEPA review pursuant to a Memorandum of Understanding between the Commission and EOEA, dated November 25, 1991.

A joint Commission and MEPA public hearing was held by a Commission subcommittee on August 6, 1998. The Secretary of EOEA issued a Certificate on the ENF on August 21, 1998 stating that an EIR was required for the project and issued a scope of review for the joint DRI/EIR. The Draft Environmental Impact Report (DEIR) was submitted to MEPA and the Cape Cod Commission on February 16, 1999. The Commission held a public hearing on Tuesday, April 13, 1999 at the Upper Cape Cod Regional Technical School to receive public testimony on the DEIR prior to the deadline for submission of comments to EOEA on Thursday, April 22, 1999. On April 29, 1999 the Secretary of EOEA notified the applicant that it was required to file a Supplemental DEIR, which was done on May 15, 2000. The Subcommittee held a public hearing on June 15, 2000 and provided comments to MEPA on the Supplemental DEIR on June 22, 2000. The Final Environmental Impact Report (FEIR) was submitted on October 16, 2000. The Commission Subcommittee held a public hearing on November 28, 2000 and provided comments to MEPA on December 7, 2000. The Secretary of EOEA issued a Certificate on the FEIR on December 15, 2000, which stated that the project "adequately and properly complies" with MEPA and its implementing regulations (301 CMR 11.00).

Following the Secretary's Certificate on the FEIR, the applicant continued with Commission DRI review. The Commission's subcommittee report of December 7, 2000 provided a comprehensive status report on the project and enumerated additional information that should be submitted to the Commission in order to allow it to adequately review the project's potential impacts. A hearing officer of the Commission opened a public hearing for procedural purposes on the DRI on January 23, 2001. A hearing officer closed the public hearing for procedural purposes on April 11, 2001.

In January 2001 the subcommittee proposed a mediation process for the month of February to allow Commission staff and the proponent to address outstanding transportation issues. The applicant agreed to a limited mediation process and a mediator was hired from the Massachusetts Office of Dispute Resolution. Four meetings were held in February 2001 with the mediator, the Commission transportation staff, the transportation consultants for CanalSide Commons, Vanasse & Associates, and William Scully of MS Transportation, representing the Association for the Preservation of Cape Cod. A meeting with all parties was held on March 2, 2001 to provide an update on the transportation discussions. Following the update and discussion the parties agreed to discontinue mediation.

A subcommittee public hearing on the project was held on May 17, 2001. Additional Subcommittee meetings to consider the project were convened on June 4, June 7, and June 15, 2001. At the June 7, 2001 meeting, the subcommittee voted unanimously to recommend to the full

Commission that the project be denied. A final public hearing on the project as proposed in the DRI/FEIR was held before the full Commission on June 21, 2001 at the Assembly of Delegates Chambers in the First District Courthouse. The public hearing was closed on June 21, 2001. At the close of the hearing, the Commission voted 15 in favor and 2 opposed to grant a 90-day extension of the Commission's decision deadline to September 28, 2001 to allow the applicant time to consider a smaller-build alternative to the proposed project.

Following this initial extension of the decision deadline, subcommittee meetings were held on August 23, 2001, September 10, 2001, October 25, 2001, April 1, 2002, October 23, 2003, November 1, 2004 and January 31, 2005 to consider additional extensions of the decision deadline and alternative development proposals. Seven additional extensions of the decision deadline (to November 16, 2001, December 7, 2001, June 7, 2002, December 6, 2002, December 5, 2003, December 7, 2004, and March 4, 2005) were subsequently granted at the subcommittee's meetings.

The project was revised several times between June 2001 and January 31, 2005. Commission staff met with the applicant on numerous occasions and evaluated the transportation implications of each alternative. One alternative, which included 138 residential units, a 300-room hotel with conference center, a 100-seat restaurant, and 13,000 s.f. of retail space, received conceptual support from the subcommittee on October 25, 2001. At the subcommittee meeting held on October 23, 2003, the applicant presented a modified project in which the applicant had increased the size of the proposal to include 57,600 s.f. of retail space including a 7,000 s.f. restaurant, 141 apartments, and a 300-room hotel/conference center. The access scheme for the site was also revised to incorporate the Upper Cape Regional Technical School driveway into the bypass road at a signalized intersection with the school.

In May 2004, the applicant indicated that he was not pursuing the proposal presented to the subcommittee in October 2003, and, instead, submitted a conceptual proposal for 600 residential units and 85,000 s.f. of retail space as a comprehensive permit-eligible project under a Local Initiative Plan (LIP), pursuant to Chapter 40B. A revised concept plan submitted on January 31, 2005 indicates that the proposal had been reduced to 391 residential units (91 proposed as apartments over retail) and 85,000 s.f. of retail space. The plans submitted were unclear as to the number of residential units that were proposed as a comprehensive permit project. In December 2004 an Approval Not Required (ANR) Plan was endorsed by the Bourne Planning Board for a portion of the CanalSide Commons site. The applicant indicated that this portion of the site was no longer under the control of the applicant.

At the subcommittee meeting held on January 31, 2005, the subcommittee voted 3 in favor and 2 opposed not to grant a further extension of the decision deadline on the revised project and to recommend to the full Commission that the project be procedurally denied without prejudice. A final public hearing was held before the full Commission on February 17, 2005 on this revised project. At this hearing, the Commission voted 9 in favor and 4 opposed with one abstention to grant a six-month extension on the project to September 9, 2005.

Additional subcommittee meetings were held on the project to discuss the status of the DRI application on July 7, 2005, July 26, 2005, September 19, 2005, and December 12, 2005. The DRI

application on a proposed 78,500 s.f. retail complex and 6,500 s.f. restaurant was deemed complete on December 21, 2005.

On February 16, 2006, the subcommittee held a public hearing at the Bourne high school auditorium on the 85,000 s.f. retail/restaurant project. The subcommittee closed the public hearing on February 16, 2006. Additional subcommittee meetings to deliberate on the proposed project were held on March 23, 2006, May 1, 2006, May 22, 2006, May 31, 2006, June 15, 2006, June 20, 2006, and July 18, 2006. Additional extensions of the decision period were granted to March 3, 2006, May 5, 2006, July 14, 2006, and August 25, 2006. At the June 20, 2006 subcommittee meeting, the subcommittee voted 3 – 1 to recommend approval of the project as a DRI, subject to conditions.

A final public hearing on the draft decision was opened by a hearing officer on June 15, 2006 and continued to July 27, 2006. On July 27, 2006, the full Commission held a final public hearing on the project in the Assembly of Delegates Chamber, First District Courthouse, Barnstable, MA. At the conclusion of this hearing, the Commission voted 11 – 3 to approve the project with conditions.

TESTIMONY

August 6, 1998 – Public Hearing on ENF/Scoping Session:

Lenord Cubellis, architect and project applicant, stated that the project would create another village in Bourne and noted that the site is zoned appropriately for the proposed development. Mr. Cubellis showed overheads of existing conditions and noted that parts of the site are heavily forested. He noted that the site is important because of the tremendous volume of traffic passing through Bourne. He said the project would improve traffic flow in the area. He showed a preliminary site design. Mr. Cubellis addressed the traffic issues, noting that his team understands the existing traffic problems and will try to find ways to solve them. In terms of the environment, Mr. Cubellis said that there is a proposal to include wind turbines in the project to provide up to 10% of the project's energy. He discussed open space and landscaping, and also discussed the wastewater treatment facility. Mr. Cubellis said that the project would create about \$1 million in annual taxes to the Town and about 1,500 jobs.

The Subcommittee asked questions of Mr. Cubellis. The staff then presented the Staff Report, with Gabrielle Belfit addressing Water Resources noting that the project site is the last remaining large undeveloped potential wellfield outside of the Town's existing well sites. Paul Tilton addressed Transportation and noted that the ENF described 25,000 vehicle trips on a weekday and 30,000 trips on the weekend as a result of the project. He said there would be significant impacts to the bridges. Sharon Rooney addressed Community Character issues and noted that the height and scale of the project, as well as the signage and parking are important community character concerns. Ms. Rooney noted that 65% of the portion of the site within a Significant Natural Resource Area is required to be open space. Ms. Rooney also addressed economic impacts. Comments from the public were received. See minutes in File 7 for more detailed information.

April 13, 1999 – Public Hearing on DEIR:

This hearing was held to receive public comment on the DEIR. Lenord Cubellis made a one-hour presentation of the project using a site map as well as a computer-generated series of overheads. Mr. Cubellis said that the proposed new traffic solution would benefit Bourne. He noted the Massachusetts Highway Department's (Mass Highway) support for the project. Mr. Cubellis discussed open space and noted the Massachusetts Military Reservation adjacent to the site. He

mentioned his programs to help revitalize Buzzards Bay. Mr. Cubellis described the existing traffic/transportation problems in the Bourne Rotary area in detail. He noted the village-style design of the proposed project and said that it would be pedestrian-friendly. He discussed jobs that would be created. Mr. Cubellis also discussed water resources, landscaping, and parking issues. Mr. Cubellis concluded by saying he believes that the project is "smart growth."

The Commission staff followed with the Staff Report and Gay Wells presented the staff's recommendation that a Supplemental Draft Environmental Impact Report (SDEIR) be required due to: 1) the need to further analyze transportation issues with regard to the access scheme and mitigation plans; 2) the need for further analysis of water resources based upon the build-out of Bourne in this area of Town and the delineation of well sites and contributing zones, plus other potential well site analyses; 3) the need for further study of the habitat and possible presence of state-listed rare species; and 4) the need for information on avian impacts, or potential bird deaths from the proposed wind generators. The issue areas in the Regional Policy Plan ("RPP") were discussed by various staff with regard to the project. Staff also discussed construction phasing. Public comments followed. See the minutes in File 7 for more detailed information.

June 15, 2000 – Public Hearing on SDEIR:

This hearing was held to receive public comment on the Supplemental DEIR. Lenord Cubellis gave a visual presentation while describing the proposed project. He noted that there are three key issues regarding the project: 1) traffic problems at the rotary; 2) protection of the environment and character of Cape Cod; and 3) providing economic benefits to Cape Cod and the Town of Bourne. He described the project as offering businesses, retail, entertainment, residential, and housing. Robert Vanasse, CanalSide transportation consultant, presented the transportation report on the project proposal. Tori Hoffman, consultant for CanalSide, discussed the open space for the project. Alex Krieger, Land Planning consultant for the applicant, stated that the currently proposed project is "smart growth" because of the uses and the compact use of space. Mr. Cubellis discussed job creation and economic benefits. Tim Downey with the Great Lakes Companies described a first-class, full-service resort hotel proposed for the project. Roger Laporte, Bourne Building Inspector, stated that at this point all of the proposals are allowed by special permit under the zoning bylaws.

Gay Wells explained the role of the Commission staff in reviewing a DRI. Ms. Wells discussed staff concerns and project alternatives. Other staff members gave summaries of the Staff Report with regard to issue areas in the RPP. Comments were received from state officials, local officials, and the general public. See the minutes in File 7 for more detailed information.

November 28, 2000 – Public Hearing on FEIR:

The purpose of the meeting was to review the FEIR. Lenord Cubellis described the project as having many desirable uses including a hotel and conference center, office and technology space, rental housing, daycare center, fitness center, and a maritime museum. He spoke about the scale of retail and the proposed housing units, as well as the provision of 120 acres of open space. Robert Vanasse, CanalSide Traffic Consultant, reported on transportation issues, stating that there are differing opinions from the Commission staff with respect to traffic and gave several examples of his disagreement with the Staff Report. Mr. Vanasse gave a visual presentation illustrating the proposed mitigation, and stated that there will be \$8 million spent in traffic mitigation. He

concluded with his belief that the project meets all of the standards in the RPP. Victoria Fletcher, Epsilon Associates, reported on the environmental impacts of the proposed project. Alan Monchoy from Kreiger & Associates reported that he believes that the CanalSide project corresponds and conforms to the RPP in the areas of Land Use and Community Character. He gave a detailed description of the project and explained the planning benefits of mixed-use development.

Gay Wells, Commission project manager, began the Staff Report presentation by outlining the major remaining issues of concern and noting that there are several other areas that require further information or analysis that are discussed in detail in the Staff Report. Ms. Wells explained the fundamental problem of locating such a large project that generates considerable traffic in the Bourne Rotary area. She stated that the staff recognizes that there are favorable aspects of the project, but added that it is important to note that there are also continuing concerns with regard to building a 900,000 square foot project at the point of entrance to the Cape. She stated that the project as currently proposed does not meet ten (10) RPP Minimum Performance Standards ("MPS") for transportation. James O'Connell spoke about Economic Development and Paul Tilton gave the Transportation report.

Comments were received from state and local officials, and the general public. See the minutes in File 7 for more detailed information.

May 17, 2001 – Public Hearing on DRI:

This public hearing was held on the DRI. Lenord Cubellis expressed frustration with the review process and the time and cost involved. Mr. Cubellis noted his demonstrated track record for reinvesting in the community. He recommended that the Bourne Conservation Trust purchase the property for open space if they wish to see it remain undeveloped.

Mr. Cubellis made comments concerning proposed traffic mitigation and believed that the mitigation would improve Level of Service on major roadways. Robert Vanasse, CanalSide transportation consultant, noted that Mass Highway and MEPA have approved the project. Mr. Vanasse said that he is perplexed at the transportation information still requested by the Commission and cited \$7 million in proposed roadway improvements. He also cited ten transportation benefits from the project.

Douglas McGarrah, attorney from Foley Hoag & Eliot, discussed the Commission's review criteria and expressed concern regarding the level of detail requested by staff.

Gay Wells, project manager for the Commission, began the Staff Report presentation by noting a number of positive aspects of the proposed project. Ms. Wells discussed the Commission's DRI review requirements and the many unresolved issues with respect to CanalSide. Ms. Wells also stated that the project is not consistent with some RPP MPSs in the areas of Transportation, Capital Facilities and Infrastructure, and Heritage Preservation and Community Character. She also noted that in the areas of Water Resources and Solid Waste Management, in particular, the materials submitted have not adequately demonstrated consistency with other MPSs.

Ms. Wells said that detailed site plans, engineering plans, grading plans, and other pertinent plans were needed because of the size and complexity of the project, and that it was not possible to adequately address the potential impacts of the project without this information. Ms. Wells also noted staff concerns with the phasing proposal, stating that the amount of development proposed for Phase 1 would not allow for the incremental monitoring of traffic impacts that phasing should provide.

Ed Eichner, Water Scientist for the Commission, provided the Water Resources report. James O'Connell gave the economic development report. Robert Mumford, Transportation Program Manager; Lev Malakhoff, Senior Transportation Engineer; and Glenn Cannon, P.E., gave the transportation report.

Mr. Mumford stated that this project projected the largest increase in traffic generation of any DRI reviewed to date by the Commission, with 20,000 trips per weekday and more on weekends. He noted that for a project of this size, mitigation would have to rely heavily on road and intersection changes. He discussed traffic generation and mitigation requirements and noted that there is inadequate mitigation proposed at certain locations, including the Sagamore Bridge. Mr. Mumford said that unmitigated traffic impacts would result in safety and congestion problems. He commented that CanalSide Commons also proposes to use fair-share mitigation funds designated for many other locations and spend them on the proposed loop ramp and bypass road. Mr. Mumford said that CanalSide's proposed use of mitigation funds would leave the Commission, the Army Corps of Engineers, MassHighway, and the Towns of Barnstable, Sandwich, Falmouth, and Bourne responsible for mitigating project impacts at as many as 29 locations without any funds to do so.

Mr. Cannon addressed traffic safety and the project's proposed access scheme, and identified unmitigated locations in several communities. Mr. Cannon explained that although CanalSide Commons had previously identified 22 locations with high accident rates, it had eliminated fifteen (15) high crash locations from their report, and had not provided information sufficient to allow Commission staff to substantiate that these fifteen high-crash locations should be eliminated from the analysis. For other high-crash locations, no mitigation is proposed.

Mr. Malakhoff noted that the staff analysis was based on knowledge of the regional road network and land use patterns. Mr. Malakhoff discussed the Cape Cod Canal area regional transportation network and discussed the capacity limitations of the Bourne Bridge, which could not be increased. Mr. Malakhoff noted that the highly congested bridges were built in the 1930s and cannot safely accommodate increases in traffic. Public comment was received. See the minutes in File 7 for more detailed information.

June 21, 2001 Full Commission hearing:

Based on the project's inconsistency with the RPP in several issue areas and incomplete information and plans for other issue areas, the Subcommittee unanimously recommended on June 7, 2001 that the project as proposed in the DRI/FEIR be denied. On June 21, 2001 the Commission held a final public hearing to review a draft denial decision as unanimously recommended by the DRI Subcommittee.

At this hearing, Mr. Cubellis proposed a 90-day extension for the purpose of working out the remaining issues with the Commission. Mr. Cubellis stated that he would agree to this extension if the Commissioners agreed to active participation in the process and agreed that the improvements proposed at the Bourne Rotary, i.e., the loop road behind the State Police barracks and the by-pass road, are viable.

Frank Shephard, Commission Chair, asked if Mr. Cubellis was considering a smaller project. Mr. Cubellis stated that a smaller mid-build project is a viable solution and it is his belief that his proposed Phase One project is a smaller build project. Commission member Robert Deane noted that the Subcommittee had asked Mr. Cubellis on June 7, 2001 if he was interested in a six-month extension; he further stated that if Mr. Cubellis were granted an extension, he would need to provide the Subcommittee with a statement describing the purpose of an extension and a detailed outline of his plans. Mr. Deane then polled the Subcommittee as to whether they were interested in pursuing a six-month extension. The Subcommittee was not in favor of an extension based on a lack of agreement on the scope of the project and the number of outstanding issues on which no progress had been made. Mr. Cubellis discussed a phased approach to approval of the project, proposed traffic mitigation and community character concerns. He also discussed a potential affordable housing proposal if the project was not approved.

Planner Gay Wells noted that the project has gone through a joint review process with MEPA and that the Commission's RPP is more stringent than requirements of the Commonwealth in many areas. She explained that for a project to be approved by the Commission it must meet all of the applicable RPP standards and the project's benefits must be greater than its detriments. She discussed the findings in the draft decision and the Subcommittee recommendation to deny the project because it does not comply with a number of the RPP standards. In addition, Ms. Wells noted that insufficient information was submitted for some issue areas.

Robert Mumford, Commission Transportation Program Manager, summarized the transportation findings in the draft decision. He described the amount of traffic CanalSide Commons would be expected to generate and identified some of the locations that would be impacted as a result. He stated that CanalSide Commons failed to comply with numerous MPSS in the transportation section of the RPP. These include standards for safety, congestion and adequate mitigation of project impacts. There was discussion of the proposed loop road and its impact on community character and an increase in delay for some drivers. There was also discussion of level of service deterioration at the Bourne Rotary as a result of the project. Commission staff explained the difficulties of phasing the approval of the project and the problems involved in monitoring traffic generation.

Public comments included a statement from Jack Howarth, former Chair of the Bourne Planning Board. Mark Tirrell, Selectmen for the Town of Bourne, expressed support for the project and an extension of the decision. Clem DiFabrio spoke in favor of the project. Correen Moore, Bourne Town Planner, requested that an extension be considered. John Ford, Chief of Police for the Town of Bourne, stated that Sandwich Road creates gridlock. He noted that the alternative to CanalSide is

residential development and he feels that the proposed project would be the best use of the land. Mark DiCicco, Chamber of Commerce, stated that the Chamber unanimously supported the project.

Maggie Geist, Executive Director for the Association of the Preservation of Cape Cod (APCC), was convinced that traffic problems will increase locally and regionally as a result of the project and urged the Commission to deny it. Patrick O'Reagan, Association for the Preservation of Bourne, also reminded Commission members that they are charged to evaluate the project with respect to the MPSs of the RPP. . Bob Ordinley of Bourne Village thanked the Commission for all their hard work and asked them to vote "no" on the project. Dick Connor, Bourne resident, commented that local officials who spoke to the Commission today did not reflect the voice of local residents. He asked the Commission to do its job and not approve a project that does not meet the MPSs. Linda Cubellis stated that there is no property for sale elsewhere in Bourne where her brother could build this project. Richard Lafarge stated that the Commission couldn't negotiate the MPSs. Jean Crocker suggested further study and reevaluation of the project. She asked that the Commission either postpone a vote, or vote to approve the project. Kate Scott, Falmouth resident, questioned the point of further extensions and asked who holds title to the property. Elizabeth DiCicco responded that her husband, Mark DiCicco, holds the title to the property; her mother stated that she used to hold the property and feels the project is appropriate for the site, but the applicant should also consider an affordable housing proposal. Susan Bonny expressed support for the RPP standards.

Sylvia Laffin, Selectman from Harwich, appreciated the concept behind the project but also the need to uphold the RPP standards. She asked that if the Commission does not vote to grant the extension that it deny the project, which would allow the project applicant to come back with an alternative proposal. Dick Driscoll, Town of Bourne, asked the Commission to grant the extension. Scott Souza, Onset resident, read a letter in support of the project. Peg Wyman, Orleans resident, felt Cape Cod has been degraded by over-development. Don Provost, Vice President of the Association of the Preservation of Bourne, believed the project should be denied. Judy Conran, Town of Bourne, feels the project is in the wrong location and that it would not ever be possible for traffic to be mitigated to meet the MPSs. A Chatham resident stated that the MPSs have not been met.

Mr. Cubellis expressed a willingness to take Phases Two and Three off the table. He would like the opportunity to document what the vehicle trips really are because he believes they are substantially lower than what is projected. He reported that the CCJTC voted to support his proposal. Ms. Wells spoke to the draft decision's findings and said that the decision was not based upon lacking information, but on a number of MPSs having not been met.

Ms. Fenn addressed the issue of an extension and the Subcommittee's belief that Mr. Cubellis did not intend to substantially modify his proposal. She also discussed mediation efforts and the lack of agreement on a proposal. Mr. Cubellis proposed a 30-day extension. Discussion ensued regarding the length of the extension, whether it would be at least six months with a statement of the purpose of the extension or a 30-day extension to explore common ground. Alan Platt suggested that with any extension, the idea of a new project would need to be discussed. Joe Travelo stated that this proposal does not meet the MPSs. Ms. Kadar proposed a 90-day extension and noted that if after

the first few meetings there is no common ground then the Subcommittee can recommend a denial; Mr. Schlaikjer said he seconded that.

Subcommittee members agreed that a new proposal would have to be brought forward. Ms. Wells stated that Mr. Cubellis has had many discussions with the staff and has not been willing to reduce the size of his project and that she believes any further discussion would not be fruitful. Ms. Kadar withdrew her motion. Mr. Schlaikjer withdrew his second on the motion. Ms. Taylor moved that the Commission deny the project. Mr. Randolph seconded the motion. Ms. Fenn stated that the applicant should have an opportunity for one final chance at presenting an approvable project. Ms. Taylor withdrew her motion to deny. Mr. Deane moved to grant a 90-day extension. Mr. Travelo seconded the motion. The motion passed with two members in opposition.

February 16, 2006 Subcommittee hearing:

Attorney Patrick Butler, representing the applicant, described the project history, its background, the application completion process, and compared the original project proposal to what was currently being proposed. He described the way the applicant believed the project met the Development of Regional Impact (DRI) standards and review criteria. He noted the modified proposal proposes all of the development in areas of the site not mapped as a Significant Natural Resources Area. Attorney Butler described the Simpson parcels and how they had been added to the site during the Commission's review. He noted the Purchase & Sale Agreement for these parcels had expired in 2005. He discussed the estimated number of vehicle trips per day from the modified project and from the original project. Attorney Butler noted the proposed bypass road and the area of the proposed 40(B) project. He showed a new sketch plan of the new proposed site access eliminating a connecting driveway from Sandwich Road to the bypass road, which dealt with staff concerns related to transportation issues and community character.

Attorney Butler discussed the project's transportation impacts, suggesting that it represented a net traffic increase with 2,550 weekday vehicle trips and 4,142 Saturday vehicle trips. He noted the proposed transportation-related mitigation parcel accounted for 1,994 daily vehicle trips.

Lenord Cubellis, project applicant, discussed the need for additional retail in Bourne. He noted that non-automobile related retail comprised 36% of commercial development in Bourne, compared to 61%-91% elsewhere on Cape Cod. He said the proposed project was a major opportunity for additional retail development and would serve local needs. Mr. Cubellis said the proposed project had been divided into eight stores on a smaller scale. He showed a series of slides illustrating different activities including a farmers' market, retail kiosks and proposed 40(B) project.

Attorney Butler concluded the applicant's presentation by stating that he welcomed public input on the project and was working towards a DRI approval recommendation by the subcommittee.

Ms. Rooney, Commission senior planner, discussed the criteria for a DRI approval. She noted because of the filing of an Environmental Impact Report in 1998 on the original project, and several extensions of the project decision period, the project was required to be consistent with the Minimum Performance Standards of the 1996 RPP. Ms. Rooney said the staff report focused on those areas where the project was not yet consistent with the 1996 RPP.

Mr. Cannon, Commission transportation engineer, commented on the three RPP transportation goals of trip reduction, congestion mitigation and safety. Mr. Cannon expressed a concern with the proposed driveway connecting Sandwich Road to the development. He said the driveway had a limited transportation benefit, and a significant amount of environment disturbance. Because of these factors, Mr. Cannon said staff recommended this driveway be eliminated. Mr. Cannon expressed a concern with the overall width of the by-pass road. He noted that the function of the by-pass road was to allow travel from Route 28 northbound to Sandwich Road eastbound. Mr. Cannon said this movement could be accomplished by a single travel lane, and noted that the by-pass road was currently proposed to be 64 feet wide, to accommodate turning lanes for the project. He said Commission staff recommended that the by-pass road width be reduced.

Ms. Linda Zuern of the Bourne Board of Selectmen but speaking as an individual testified in favor of the proposed project. She noted Bourne needed more local shopping opportunities, so that residents could shop in town. Ms. Zuern said the land was zoned for commercial use. She said the proposed project was too small and suggested that a project with a hotel component was more appropriate. She said Bourne would benefit from room taxes if a hotel were part of the project.

Mr. Chris Farell, representing the Bourne Police Department, spoke in favor of the proposed bypass road. He also favored leaving the bypass at 64 feet and the one-way connector to Sandwich Road. He said queuing at the rotary could be addressed, and did not support sidewalks on Sandwich Road. Mr. Farell also spoke in favor of adding a hotel component to the project.

Mr. Barry Motta, Superintendent of the Upper Cape Regional Technical School, spoke to the need for safety mechanisms at the bottom of the school's driveway onto Sandwich Road, even though crash data did not bear this out. He said that without a police detail, there would be more serious accidents. He spoke in favor of the "big build/Plan A" alternative. He also spoke in favor of a tie-in to the project's proposed wastewater treatment plant for the school, and said he believed the project was a benefit to Bourne.

Mr. Richard LaFarge, of the Bourne Board of Selectmen, said he was speaking for himself. He noted the DRI test that a project's benefits had to outweigh its detriments. He noted that Sandwich Road and the rotary were major roads. He expressed concern about additional uses on site, such as possible apartments. He said the proposed bypass was not a true "bypass," in that it served the proposed project. He expressed concern about transportation safety issues, and the mixing of school and project-related traffic. He said police officer control at the school's driveway was not adequate to address the issues. Mr. LaFarge said he did not think the project's benefits outweighed its detriments.

Ms. Ann Bronti spoke in favor of the project. She noted the proposed bypass as a key feature, and suggested that a development between the size of the original proposal and current proposal be considered.

Mr. Andrew Cooney asked to speak as a member of the Bourne CanalSide Task Force, which was established to investigate possible acquisition of the site as open space. He noted the need to look at

open space purchases, and future uses of the site. He expressed concern about the traffic impacts at the rotary and on the road network.

Ms. Maggie Geist, Executive Director of the Association for the Preservation of Cape Cod (APCC), said APCC was pleased to see a smaller retail proposal, but was still concerned about traffic impacts. She said the unadjusted trip generation numbers should be used, without consideration of "internal capture" rates. She noted the traffic mitigation did not address trips from the proposed 40(B) project, some 3,000 estimated trips. Ms. Geist said the proposed bypass had limited benefits, and that many vehicles would still end up passing through the rotary. She recommended the number of site driveways be reduced.

Mr. Patrick Shelly expressed support for the original project. He said that residential development was a major traffic contributor. He did not think sidewalks or the commuter lot were appropriate.

Mr. Michael Fravich said Bourne was a difficult place to do business in. He said the town had limited infrastructure, and expressed concern that the local government did not have a commerce department, to assist businesses. Mr. Fravich expressed support for the original project.

Mr. John Schmidt expressed concern that the project was proposed adjacent to the landfill and transfer station. He expressed concern about project traffic, including whether the traffic studies had been done during peak times.

Ms. Kathy Lavelle, President of the Association for the Preservation of Bourne, said the project was not consistent with the RPP or local zoning. She questioned whether MassHighway had granted the proposed project curb cut permits. She said a police officer was preferred to a signal at the technical school driveway. She expressed concern about traffic safety issues. Ms. Lavelle expressed concern about the amount of proposed clearing and grading. She questioned whether the potential tax revenues were worth the traffic impacts, safety issues, and community character impacts.

Ms. Linda Cubellis said it was worth considering the number of trips going through Bourne and not stopping. She suggested the project would attract many people interested in the retail employment.

Ms. Sallie Riggs read a portion of a comment letter on behalf of the Bourne Financial Development Corporation in support of the project contingent on the project showing the economic benefits, over-55 and workforce housing benefits, open space preservation, and traffic/safety mitigation as presented.

Mr. Joseph Carrara, of the Assembly of Delegates, said he was speaking as a private citizen. He commended the Commission as a regional agency. At the same time, he said impacts and benefits to Bourne should be considered. He questioned the staff report comment that the project would not result in an economic benefit. Mr. Carrara expressed support for the original project concept.

FINDINGS

The Commission has considered the application of Lenord Cubellis for the proposed CanalSide Commons project, and based on consideration of such application and upon the information presented at the public hearings and submitted for the record, makes the following findings pursuant to Sections 12 and 13 of the Act:

General

G1. The proposed project consists of the development of a 78,500 s.f. retail complex and a 6,500 s.f. restaurant on an approximately 153-acre site located on Sandwich Road and the Bourne Rotary in Bourne, MA. The applicant proposes to construct the project in two phases of 50,820 s.f. (Buildings A, B, G, & H) and 34,180 s.f. (Buildings C, D, E, & F), as described on a Construction Phasing Plan, Cubellis Associates, Inc. received June 7, 2006. The applicant has proposed to construct a bypass road behind the Bourne Rotary from Route 28 (MacArthur Boulevard) to Sandwich Road to provide access to the site. The project plans also include an approximately 5.3 - acre area (portions of Assessor's Map 24, Lot 13.1, Book 13688, Page 241, and portions of Assessor's Map 25, Lot 3, Book 13688, Page 241), to the front of the site and adjacent to the proposed bypass road that has not been designated for any specific use.

G2. The proposed project has been revised from an approximately 1,000,000 s.f. mixed-use development previously reviewed under MEPA regulations. The applicant agreed to proceed with a joint DRI/MEPA review pursuant to a Memorandum of Understanding between the Commission and EOEA.

G3. The majority of the site is undeveloped and wooded, with the exception of an area that contains a former motorbike track, and is currently occupied by unauthorized recreational activities. The Upper Cape Regional Vocational Technical High School is adjacent to and north of the site. The Massachusetts Military Reservation (MMR) forms the eastern boundary of the project site and the Bourne landfill is approximately 3/4-mile south of the project site. The site is currently zoned B2 and B3 Business. The proposed project would require a special permit from the Bourne Planning Board.

G4. During prior joint DRI/MEPA review, the project site increased to approximately 183 acres with the addition of an approximately 5-acre former motel site immediately west of the original project site, and 25 acres of land immediately south of the original CanalSide property. The applicant has demonstrated through the submission of affidavits that this additional 30 acres of land is no longer under the applicant's control and therefore the project site totals 153 acres.

G5. The project was subject to review under the 1996 RPP. The Commission and the Barnstable County Assembly of Delegates adopted a new RPP in 2002. However, extension agreements allowed the applicant to continue to be reviewed under the 1996 RPP.

Land Use

LU1. MPS 1.1.1 encourages *compact forms of development such as cluster development, redevelopment within certified growth/activity centers, and, where appropriate, mixed-use residential/commercial development in order to minimize further land consumption and protect open space*. The proposed project is clustered on a portion of the site that was previously disturbed by unauthorized recreational activities, consistent with this MPS. The applicant has provided information concerning the potential future construction of 75 to 150 apartments to be located on the second level of the retail buildings proposed for the project. The applicant has provided architectural design of the buildings in the event construction of such "above the shop" apartments should occur in the future. Such addition of multifamily use to the project site would require review as a new DRI pursuant to Section 12 of the DRI Enabling Regulations (Barnstable County Ordinance 90-12[as amended]).

Water Resources

WR1. The proposed CanalSide Commons site is located within a Potential Public Water Supply Area (PPWSA) and within the watershed to the Cape Cod Canal.

WR2. The applicant is proposing 78,500 square feet of retail space and 150 restaurant seats; these uses will result in a Title 5 wastewater flow of 9,200 gallons per day. A standard Title 5 septic system will be used to treat wastewater on the site.

WR3. The majority of the proposed CanalSide Commons site is located within a Potential Public Water Supply Area (PPWSA) as defined in the RPP and shown on RPP Water Resources Classification Map I. In addition, the Priority Land Acquisition Assessment Project (CCC, 2001) identified the CanalSide Commons site as the only high ranked parcel in Bourne south of the Cape Cod Canal and outside of the MMR because MMR-associated contaminant plumes do not intersect it, as are other available properties in the town. Previous analyses indicate that preservation of the eastern portion of the site would allow the site to host a future public water supply well with a DEP-required 400 ft protective radius or provide a protected, undeveloped area for public water supply wells that have been considered within the MMR. The applicant has proposed to preserve the eastern portion of the site with a conservation restriction that will allow future use of that area for public water supply development.

WR4. Projects in PPWSAs are required to meet a 5-ppm nitrogen-loading limit under MPS 2.1.1.2.F.2. and MPS 2.1.1.1. of the 1996 RPP. Use of a standard Title 5 septic system to treat the proposed wastewater flows, along with the consideration of proposed fertilized landscaping and impervious surfaces, will result in a nitrogen loading concentration of 2.4 ppm, below the 5-ppm limit.

WR5. The stormwater minimum performance standard (MPS 2.1.1.6) in the 1996 RPP requires the use of best management practices (specifically mentioning vegetated swales) to minimize runoff and maximize treatment, development of a system maintenance schedule, and design based on a 25 year-24 hour storm.

WR6. The applicant has proposed a stormwater design and plan that meets MPS 2.1.1.6 of the 1996 RPP.

Natural Resources/Open Space

NR1. The applicant filed an application for joint review with MEPA and the Cape Cod Commission in July 1998. In that application, the applicant described the project area as 152 acres. The open space requirement was determined to be between 76 and 91.2 acres, depending on the size of the site areas located in and outside of the area mapped as Significant Natural Resource Area (SNRA).

NR2. In the DEIR filed in February 1999, the applicant's calculation of the project area increased to 157.6 acres, with a consequent increase in the approximate open space requirement to 96.5 acres.

NR3. In the FEIR filed on October 31, 2000, the applicant added approximately 25 acres to the site area, bringing the total to 183.3 acres, and provided calculations that the project would be required to provide 103.5 acres of open space. Commission staff's calculation of the open space requirement at the time of the November 21, 2000 staff report was 110.2 acres.

NR4. At the July 7, 2005 subcommittee meeting, the applicant presented a conceptual CanalSide Commons retail site plan, dated January 28, 2005 and received by the Commission on May 31, 2005, in which the entire 183.3-acre site was shaded.

NR5. In the most recent changes to the site plan, the applicant has documented that approximately 30 acres of the site area (owned by Fiddler's Green Limited Partnership, also known as the Simpson parcels) are no longer under the applicant's control, and consequently the site area is now 152.2 acres. Based on the applicant's calculations of site area located in and out of SNRA, the open space requirement for the project is 93.1 acres.

NR6. The applicant and the owners of the Simpson parcels submitted affidavits in July 12, 2005 and February 3, 2005, respectively, which state that there is no longer any common ownership or control between the parties.

NR7. It is appropriate to require open space based on the applicant's statement of the current project size, 152.2 acres, noting that should the applicant add one or both of the Simpson parcels to the project site in the future, that open space for this land should be required based on the requirements of the 1996 RPP based on the anti-segmentation provision in Section 2(a)(iii) of the DRI Enabling Regulations.

NR8. A 93.1-acre area proposed to be protected open space on the site is located to the east (rear) and southern boundaries of the site. These portions of the site are the most sensitive, including a narrow valley, or "frost bottom", and rare species habitat located to the east, and are proximate to a growing band of protected land to the south. Consequently the proposed open space is consistent with the requirements of MPS 2.4.1.2, 2.4.1.3, 2.5.1.1, 2.5.1.2, 2.5.1.5, and 2.5.1.6.

NR9. The applicant intends to protect the open space through a conservation restriction held by an appropriate conservation entity. The land will be made publicly accessible, while providing for the habitat protections discussed below on the 93.1-acre parcel, subject to addressing the concerns of Massachusetts Military Reservation officials.

NR10. Since a portion of the site is located in mapped rare species habitat, the applicant submitted a request for comments from the Natural Heritage and Endangered Species Program (NHESP). NHESP responded on June 26, 2000 that based on the original project (which is consistent in terms of the area of the site to be impacted by development with the current proposal), that they did not anticipate adverse impacts to state listed species. NHESP recommended that the recreational activities within the open space area be limited to avoid adverse impacts to state listed wildlife, and requested that provisions for habitat management be allowed for in the conservation restriction.

NR11. While the Bourne Water District has stated that they do not intend to develop a new water supply on this property, the conservation restriction will allow for development of a water supply on the 93.1-acre parcel.

NR12. The present proposal locates development away from potential vernal pools located in the southern corner of the site adjacent to the proposed bypass road, and thus is consistent with MPS 2.4.1.5.

NR13. The proposed clearing and grading at the front of the site near Sandwich Road/MacArthur Boulevard associated with the bypass road will significantly alter the slope approaching the project development site, which is inconsistent with MPS 2.4.1.2, and which may have significant impacts on views of the site from the Bourne Bridge. The applicant has proposed to revegetate these slopes with erosion control mix, conservation mix and a variety of native tree and shrub saplings to mitigate the natural resources impacts to this area.

Economic Development

ED1. Goal 3.1 of the RPP is to *promote businesses that are compatible with Cape Cod's environmental, cultural, and economic strengths in order to ensure balanced economic development*. DRP 3.1.2 instructs the Commission to *evaluate the impact of the project relative to the information provided*. The following findings are based on the analysis of information provided by the applicant:

1. Net job creation: According to the applicant, the project is estimated to generate 126 full-time equivalent positions. The percentage of employment that will be full-time, part-time, or seasonal is unknown.

Also unknown is the total payroll to be generated, the average wages to be paid, the types of jobs expected, or the potential benefits associated with those jobs. On average, 2003 average weekly wages for retail trade in Barnstable County were \$467/week, compared to the average for all industries of \$636/week. Only the Accommodation & Food Service and

Other Services industries have lower average weekly wages than retail (\$346/week and \$464/week respectively).¹

2. Services/products provided: The project as currently proposed consists of retail and restaurant trade and no specific tenants have been identified to date. The proposed sizes of commercial space set forth below are approximations only based on gross square footage. The exact size of particular leased commercial space will be determined based upon final negotiation of tenant leases.

Within the context of the Commission's charge to ensure a balanced regional economy, the addition of 78,500 square feet of retail and 6,500 square feet of restaurant space will serve to further concentrate commercial development in the region's two largest employment sectors. Bourne's share of the region's retail development is currently 7.6% overall, while Bourne's share of the region's population is slightly higher at 8.4%. It is worth noting that in terms of sales, Bourne generates 8.9% of the regional sales, greater than their share of the population, and while a healthy share of this is from auto sales, approximately 50% of retail sales and 75% of retail employment in Bourne comes from other, non-auto related retail activity³. The applicant has argued that this development will reduce sales leakage from Bourne to surrounding towns. Using standard calculations of local sales surplus and leakage⁴, Bourne actually shows a surplus for total retail sales relative to both the county and the state. In fact, with the exception of the town of Barnstable, Bourne retail sales surplus is greater than all the other towns on the Cape for which data is available (Brewster, Dennis, Falmouth, Harwich, Mashpee, Sandwich, and Yarmouth). When auto-related sales are removed,

Bourne shows some sales leakage relative to the county's total non-auto related sales but still fares better than both Falmouth and Yarmouth, two of the three comparison locations provided by the applicant. Therefore, given the structure of the regional economy, this project will not advance economic diversity or add balance to the regional economy, nor will the local impact on consumer choice be significant enough to be considered a regional benefit.

3. Local ownership and resident employment: Information indicating how or if the project would house locally owned businesses or seek to employ Cape residents was not provided.
4. Other: The applicant provided the following additional information on the project:
 - a. Total Investment: \$19 Million with approximately \$10 – 12 Million in total construction costs, to be spent over an estimated 18-month construction period.
 - b. Estimated increase in property tax payment: expected payment (\$159,737) minus current payment (\$11,500) equals \$148,237 per year. Property tax revenue in 2006 was \$29,448,172 for the Town of Bourne. This addition would represent a .5% increase of the Town's tax base.

The project has not demonstrated benefits relative to the remaining DRPs under Goal 3.1 that are relevant to this project:

- DRP 3.1.3: Encourage enterprises with the greatest economic potential (essential or emerging industries)
- DRP 3.1.4 Encourage tourism activities that enhance natural and cultural qualities of Cape Cod and that promote year-round activity.
- DRP 3.1.5: Encourage development of local business.

ED2. Goal 3.2 of the RPP is to *locate development so as to preserve the Cape's environment and cultural heritage, minimize adverse impacts, and enhance the quality of life*. The section provides only one MPS focused on incentives for projects within certified growth/activity centers. This project is not in a certified growth/activity center and therefore MPS 3.2.1 does not apply. In terms of the DRPs under Goal 3.2, the project has not demonstrated benefits relative to the following:

- DRP 3.2.2: Development should be concentrated in growth centers
- DRP 3.2.3: Village centers should be maintained and restored by concentrating small-scale retail, office, home-based industry, and community activities in these areas.
- DRP 3.2.4: Large-scale commercial activities should be concentrated where adequate infrastructure is available
- DRP 3.2.7: Redesign, revitalization, and infill of existing strip commercial developments.

ED3. Goal 3.3 of the RPP is to *encourage the creation and diversification of year-round employment opportunities*. The project has not demonstrated regional benefits to year-round employment, access to health and retirement benefits, employment of local workers, higher than minimum pay levels, or financial support of training programs and/or affordable housing, as

specified under DRP 3.3.1. The project has not demonstrated benefits relative to the other DRP's in this section:

- DRP 3.3.2: Encourage projects providing permanent, well-paying, year-round jobs & training opportunities
- DRP 3.3.3: Encourage projects that employ Cape Cod contractors, workers, and use local suppliers
- DRP 3.3.4: Encourage projects to hire minority and women contractors and employ minorities, disabled, elderly, unemployed and underemployed in permanent positions.

Transportation

T1. As stated in the Traffic Impact and Access Study, the proposed development is expected to generate 6,110 vehicle trips on an average weekday. The expected net increase in traffic from the project, after allowing for the retail/residential internal capture rate, a 20% trip reduction (as required under MPS 4.1.2.1) and 25% pass-by rate, is as follows:

T2. The Regional Policy Plan requires Developments of Regional Impacts to identify all year-round and summer transportation impacts caused by the development on all regional road links and intersections where the project is expected to add 25 new trips during the project's peak hour. This threshold is increased to 50 trips for regional intersections and road links within certified growth centers.

Based on the trip generation and trip distribution information provided by the applicant in the Traffic Impact and Access Study, thirty-six (36) regional intersections and forty (40) regional links were identified and analyzed in accordance with the Regional Policy Plan. The appropriate regional intersections and regional links are included in the traffic study.

T3. MPS 4.1.1.7 requires that *regardless of project size or traffic generation, there shall be no degradation in public safety as a result of a DRI*. Based on the applicant's traffic report, five (5) of the intersections impacted by more than 25 peak hour trips from this project have three or more crashes per year and/or a crash rate higher than the state average. All of these intersections are within the Town of Bourne.

The applicant has offered safety mitigation at all five high crash locations to offset the degradation in public safety caused by the development. The applicant's safety mitigation is outlined in the table below.

T4. The applicant has proposed design and signalization of the Sandwich Road/ Upper Cape Technical School driveway as part of the Bypass Road construction. Although this intersection was not identified as a high crash location, this mitigation is the most significant safety improvement proposed by this project. A new intersection off the Bypass Road will provide access to the Upper Cape Technical high school.

T5. MPS 4.1.1.6 requires all new driveways on regional roads to operate at Level of Service (LOS) C or better as defined in the Highway Capacity Manual. Based on the Highway Capacity intersection analysis submitted by the proponent, the proposed Bypass Road driveways will operate at better than LOS C under build conditions.

T6. As stated in Transportation Finding T3, thirty-six (36) regional intersections and forty (40) regional links were identified and analyzed in accordance with the Regional Policy Plan. The applicant has compiled and submitted to the Commission a fair share cost analysis following Technical Bulletin 96-003, Part 2 – Fair Share Overview and Methodology Guidelines. The applicant must mitigate 452 Saturday midday vehicle trips to comply with MPS 4.1.1.1 of the RPP. The fair share cost to offset 452 Saturday midday peak trips has been calculated by Vanasse Associates, Inc., at \$1,895,740. The applicant has proposed to apply the fair share cost to the Bypass Road as shown on the Vanasse Associates Plan titled Preliminary Conceptual Improvement Plan dated March 21, 2006. The proposed Bypass Road structural mitigation planned is outlined in the safety mitigation table (Transportation Condition T1) listed underneath the Bourne Circle.

T7. Prior to CanalSide Commons constructing mitigation at these locations, if any other parties (public or private) construct traffic improvements or traffic mitigation at any of these locations that makes the applicant's proposed mitigation unnecessary or impractical, the applicant shall pay an amount equivalent to that proposed mitigation cost at those locations to the County of Barnstable/Cape Cod Commission. Such payments in lieu of in-kind traffic mitigation are necessary to comply with MPS 4.1.1.1 and shall be used to support transportation improvements in the Town of Bourne.

T8. The applicant has agreed to commit \$104,500 for the roadway mitigation as allowed by Regional Policy Plan ODRP 4.1.1.20. These funds will be held in a mitigation account at the Barnstable County/Cape Cod Commission and shall be applied towards transportation improvements in the Towns of Bourne, Falmouth, Sandwich and Barnstable (study area towns impacted by this project) as outlined in Transportation Condition T3.

T9. All DRIs are required to reduce or offset new vehicle trips in and out of the site by 20% over what is typically expected for the land use (MPS 4.1.2.1). Based on the increase in average daily traffic of 5,682 trips per day adjusted for internal capture with the proposed 40B development, the trip reduction requirement for this project is 1,136 daily vehicle trips. As part of the overall trip reduction plan, the applicant has proposed an employee/patron trip reduction program as provided under Transportation Condition T6.

T10. The applicant has proposed to donate approximately 90,978 square feet of vacant developable land (approximately 2.0 acres) off Sandwich Road in Bourne, in excess of open space requirements, to a conservation land trust to meet the remaining trip reduction requirements and as a benefit to offset the existing traffic congestion in the area. The parcel of land is identified on Open Space Analysis Plan, Cubellis Associates, revised June 12, 2006. This vacant developable land has the potential to generate 2,466 daily trips, more than the 1,136 (5,682 x 20%) trips required under the RPP. The donation of vacant developable land in excess of open space requirements as an offset to the trip reduction requirements of the RPP is allowable under DRP 4.1.3.2.

T11. MPS 4.1.1.11 requires in part that *road widening, intersection widening or new traffic signalization be consistent with community character and not have an adverse impact on historic, scenic or natural resources*. The existing topography immediately surrounding and including the CanalSide site varies from a low of approximately 50' (adjacent to the Old Sandwich

Road/Sandwich Road intersection) to over 125' in the center of the proposed development area. Construction of the bypass road, a secondary one-way access along Renaissance Drive, and the proposed drainage design for the project will all result in a significant amount of clearing and grading between Sandwich Road, MacArthur Boulevard and the project site. As noted in finding NR13, the applicant has proposed to revegetate these slopes with erosion control mix, conservation mix and a variety of native tree and shrub saplings to mitigate the natural resources impacts as a result of construction of the proposed bypass road.

T12. To mitigate the community character impacts as outlined in MPS 4.1.1.11, the applicant has agreed to provide ornamental mast arms and/or ornamental signal heads, and related ornamental signal equipment at all new signalized locations, and alternative paving treatment for any crosswalks.

T13. The applicant has agreed to provide an easement across the applicant's property from the Simpson parcel, Assessor's Map 24, Lots 13 and 13.2, Book 13315, Page 84, traveling south to allow for access to the bypass road for development of the Simpson parcel. Such an easement shall be at a location mutually agreed upon by the applicant and Simpson and shall be subject to the reasonable terms and conditions to be negotiated by and between the applicant and the owner of the Simpson parcel.

T14. The applicant has agreed to clear and maintain a 1200' long by 15' wide pathway between the Gallo Arena and the proposed entrance driveway on Sandwich Road.

T15. In accordance with condition T-4, the applicant is required to design and construct a bypass road as shown on the preliminary conceptual improvement plan dated March 21, 2006 by Vanasse Associates, Inc. The applicant shall, in order to dedicate the bypass road as a public way, prepare, file and record a subdivision plan in accordance with Massachusetts General Law Chapter 41, Section 81-L. A copy of the subdivision plan as endorsed by the Planning Board of the Town of Bourne shall be submitted to the Cape Cod Commission for the record. The applicant shall consult with the Bourne Board of Selectmen and MHD regarding acceptance of the road as a public way and/or state road prior to dedication.

T16. The applicant has agreed to fund a study for the Town of Bourne regarding the feasibility and design of sidewalks from the Bourne High School to the project site. The applicant may seek to utilize portions of the funds identified in finding #T9 for actual construction of sidewalks as outlined in the feasibility study.

T17. MPS 4.1.1.14 requires developments *to provide adequate parking* and MPS 4.1.1.15 requires that *parking facilities for DRIs be limited to the needs identified in a Commission approved parking study or the requirements of local communities, whichever is greater*. According to an analysis prepared by the Bourne town planner on July 17, 2006, the Bourne zoning bylaw requires a minimum of 491 parking spaces for the proposed retail and restaurant uses on the site. The applicant has proposed a total of 538 parking spaces, including 47 spaces as reserve parking for potential future apartments above the retail uses. This reserve parking area exceeds the town

requirement of 491 spaces. The reserve parking area will remain as a grassed or landscaped area unless and until a DRI approval is granted for proposed apartments over the retail uses.

Solid Waste

SW1. MPS 4.2.1.1 requires the applicant to *address how waste will be diverted, to the maximum extent possible, away from disposal facilities (landfills and incinerators) and be composted and/or recycled, per the integrated solid waste management system outlined in the standard.* According to information supplied by Epsilon Associates, a Solid Waste Management Plan has been prepared (refer to Volume II, Section 2.5 of the Draft Environmental Impact Report) that details the manner by which waste will be diverted from disposal facilities and recycled. As such, the applicant has met this solid waste standard.

SW2. MPS 4.2.1.2 requires the applicant to *allocate adequate storage space for interim storage of recyclable materials.* As outlined in the Management Plan, an on-site recycling coordinator will ensure that the retail complex will provide the necessary infrastructure for the recycling of all recyclable materials. In particular, the retail complex will be required to recycle waste cardboard and will provide the infrastructure for the collection and disposal of plastic and tin containers. As such, the applicant has met this solid waste standard.

SW3. MPS 4.2.1.3 requires the applicant to *manage construction wastes (asphalt, brick, concrete, wood, sheetrock and metals) in a manner consistent with the integrated solid waste management system outlined in MPS 4.2.1.1.* A Solid Waste Management Plan has been prepared that addresses the types and amounts of construction wastes that will be generated during the construction phase of the proposed project. The Management Plan details how the materials will be stored on site, how the materials will be separated into separate zones for recycling, and those materials that cannot be recycled will be disposed of in a permitted landfill. As such, the applicant has met this solid waste standard.

Hazardous Materials/Waste

HAZ1. MPS 2.1.1.2.F.2 restricts *commercial and industrial development and redevelopment that involves the use, treatment, generation, storage or disposal of hazardous wastes or hazardous materials* in Potential Public Water Supply Areas (PPWSAs). According to 1996 RPP maps, part of the site is located in a PPWSA. However, based on plans submitted by the applicant, the revised project will be located entirely outside of the PPWSA-mapped area. The applicant has also agreed that fueling and re-fueling of construction equipment will occur on designated areas that are outside of the PPWSA.

HAZ2. MPS 4.2.2.1 requires that *development and redevelopment shall make reasonable efforts to minimize their hazardous waste generation through source reduction, reuse, material substitution, employee education and recycling.* The DEIR for the original project stated that hazardous materials attributable to construction would include diesel fuel, hydraulic oil, lubricating oil and grease. The DEIR, FEIR and SFEIR did not address methods to reduce hazardous waste generation from construction.

HAZ3. MPS 4.2.2.2 requires that *development and redevelopment shall be in compliance with Massachusetts Hazardous Waste Regulations, 310 CMR 30.00*. The DEIR for the original project described methods to collect, handle, store and dispose or recycle hazardous materials and hazardous waste attributable to construction activities. To be consistent with MPS 4.2.2.2, servicing of construction equipment should be limited to greasing of fittings and joints, and on-site "heavy" maintenance should be prohibited. Any equipment fueling should occur on an impervious surface with spill containment. A May 3, 2001 submission from the applicant states that requirements like these will be incorporated into construction bid documents. This is sufficient to address MPS 4.2.2.2 for the project's construction phase(s).

HAZ4. Regarding management of hazardous materials and wastes in the project's post-construction phase, the applicant has indicate that building heating will be provided by natural gas, and that the applicant will address MPS 4.2.2.1 and 4.2.2.2 through lease restrictions and by providing tenants with educational materials.

Air Quality

AQ1. MPS 2.6.1.1 requires that DRIs *shall be in compliance with the Massachusetts State Implementation Plan (SIP) and DEP's Air Pollution Control Regulations, 310 CMR 7.00*. For the revised project, noise sources are likely to include construction/site clearing activities, building mechanical equipment, emergency generators (if any), and noise related to tenant businesses, including the proposed restaurant. Noise attributable to site traffic has also been a concern during the DRI review. The revised project configuration eliminates a previously proposed loop road, with site access provided solely by a bypass road from Route 28 (MacArthur Boulevard) and Sandwich Road.

AQ2. The DEIR and a November 29, 2005 Memo from Cubellis Associates, Inc. addresses noise impacts from construction activities, and describes ways to attenuate sound from these activities and HVAC equipment through a combination of mufflers, building design, acoustical treatments and restricting hours of construction. These actions, and elimination of the loop road, are sufficient to address MPS 2.6.1.1 for this project.

Affordable Housing

AH1. The applicant on December 29, 2005 filed its application with MassHousing for a Chapter 40B site eligibility letter for a 300-unit ownership development on the site. Per Section 13J of the Act, the Commission is considered a local board for Chapter 40B permit applications.

Heritage Preservation/Community Character

CC1. The Massachusetts Historical Commission (MHC) found on July 21, 1998 that the CanalSide Commons project was unlikely to impact significant archaeological resources. An intensive (locational) archaeological survey was conducted by PAL, Inc. in consultation with the

Massachusetts Historical Commission (MHC) and the Wampanoag Tribe of Aquinnah. The survey concluded that the site does not support any significant archaeological resources.

CC2. The proposed project includes 8 buildings, labeled A through H, all fronting on a proposed "village green" and along the proposed Bypass Road. The applicant submitted a complete set of building plans and elevations, including roof plans, dated 9-29-05 (Buildings A through F) and 9-28-05 (Kiosk and Building G). All buildings are proposed to be single story, with multiple entrances for commercial tenants, and glass display windows on the front facades. Rear facades have primarily clapboard walls with service entrance doors.

CC3. The proposed design is consistent with RPP Performance Standard 6.2.1, which requires the height and scale of new buildings to be compatible and harmonious with its site. This standard also requires that no new development have a single structure with a footprint greater than 50,000 square feet. None of the structures in the proposed Canalside Commons exceeds a footprint of 50,000 square feet. The largest buildings, Buildings A and B, have a footprint of approximately 26,000 square feet. Buildings C and D each have a footprint of approximately 12,000 square feet. Buildings E and F are each approximately 5,600 square feet. The kiosk and Building G are approximately 2,000 square feet each.

CC4. In reviewing larger buildings with facades over 100 feet long, the Commission has used a rule of thumb that calls for at least 10 feet of façade variation for every 50 feet of façade length. The long façades of Buildings A, B, C, and D do not have this level of variation in their building footprint. Buildings A and B provide approximately 30 feet of façade variation for façades of 190 feet and 250 feet in length. Buildings C and D provide approximately 20 feet of façade variation for façades approximately 170 feet long. Addition variation in the roof forms of the proposed buildings, as well as in the building materials and display windows, will help to break down the building mass. As final building plans are prepared to accommodate incoming tenants, any design modifications should include additional footprint and façade variation and should not lessen the amount of variation shown in the approved plans.

CC5. The proposed design is consistent with RPP Performance Standard 6.2.2, which requires the mass and scale, roof shape, roof pitch, and proportions and relationships between doors and windows to be consistent with traditional Cape Cod architectural styles. The style of the proposed buildings, and the use of hip and gable roof forms, wood clapboard and shingle siding, and wood architectural detailing is consistent with this standard, and also with Review Policy 6.2.18 which recommends the use of traditional building materials for new construction.

CC6. MPS 6.2.10 requires that *parking be located to the rear or side of a building or commercial complex in order to promote traditional village design in commercial areas unless such location would have an adverse or detrimental impact on environmental or visual features on the site, or is completely infeasible*. The project plans include a total of 542 parking spaces broken up into smaller lots. The majority of the parking is provided to the side or rear of the buildings, consistent with MPS 6.2.10. A total of 64 spaces are proposed to the front of proposed retail buildings, which is inconsistent with MPS 6.2.10.

CC7. Traditional village design is characterized in part by on-street parking to provide safe and convenient pedestrian access to storefronts. The intent of the applicant's design is to promote traditional village design through a series of smaller-scaled retail buildings connected by one-way internal streets with on-street parking and small parking lots.

CC8. Access to the project site is proposed by construction of a bypass road that is primarily automobile-oriented, with limited pedestrian activity due to the lack of other surrounding development. Three of the proposed retail buildings are located immediately along the new bypass road. The provision of a limited amount of on-street parking directly in front of these buildings would promote a more village-style design.

CC9. The applicant has provided a 16 to 36-foot vegetated buffer and 3 to 4 - foot earthen berm between the 64 parking spaces and the bypass road in order to mitigate the visual impact of the parking from this new regional roadway. The location of this parking in front of the buildings will not be more detrimental to the protected resource than would be allowable under MPS 6.2.10.

CC10. MPS 6.2.5 requires *landscaping that integrates buildings with their environment, enhances architectural features and provides amenities for pedestrians shall be provided by all new development*. MPS 6.2.6 also requires *all development to implement a landscape plan which addresses the functional aspects of landscaping, such as drainage, erosion prevention, and screening*. The applicant proposes to create a walkable, compact, urban form of development through a cluster of eight buildings connected by a series of walkways and surrounding a central green with gazebo and benches. The proposed landscape plan includes a variety of trees and shrubs that are suitable to the site. The applicant also proposes movable landscape planters throughout the development site.

CC11. The landscape plan includes benches, bike racks and other site amenities consistent with MPS 6.2.5. The applicant also proposes to revegetate areas disturbed as a result of clearing and grading for the proposed bypass road with native grasses and tree/shrub saplings, and has implemented some LID design techniques into the project design. While not a requirement under the 1996 RPP, the applicant has agreed to provide a 3-year maintenance agreement for all proposed landscaping, including revegetated slopes associated with construction of the proposed bypass road.

CC12. MPS 6.2.7 of the 1996 RPP states that *exterior lighting...shall comply with standards including design, light source, total light cutoff and foot-candle levels as defined in...Technical Bulletin 95-001*. A *Landscape & Lighting Plan* (sheet C-9, Cubellis Associates, dated 10/3/05) shows the approximate location of pole-mounted site lighting. Later submissions indicate that the proposed pole-mount lights are consistent with Technical Bulletin standards 2.1 to 2.4. This information also indicates some lights (denoted as *BB*) will have a 25-foot mount height. Standard 2.5 of Technical Bulletin 95-001 sets a 20-foot limit on pole-mounted lights for developments that abut residential areas, regional roadways, or are visible from public roads. This pole height was increased to a 25-foot height to reduce the number of light poles and light fixtures. The 25-foot pole height may also provide some long-term benefits by reducing energy use. The application did not address whether any other fixtures will be used as part of the project, including but not limited

to lights that would be attached to proposed buildings (wall-packs), any recessed fixtures, landscaping accent lights or bollards.

CC13. Technical Bulletin standard 2.6 sets a maximum foot-candle level of 8.0 as measured directly below the luminaire at grade. Foot-candle plans submitted by the applicant to date appear to indicate compliance with this standard, except that these plans may overly reduce the fixtures' maximum light output.

CC14. The applicant has submitted schematic signage information and a design narrative indicating that proposed building and pylon signs will be painted wood or carved and externally illuminated or back-lit as required by MPS 6.2.8. The proposed building elevations indicate the location of building signs along a sign band placed below the eave, which is acceptable to staff. Detailed signage plans including materials, placement on the site and proposed method of illumination should be required prior to issuance of any building permits for staff review and approval.

CONCLUSION

Based on the findings above, the Commission hereby concludes:

The probable benefits of the proposed project outweigh the probable detriments as supported by findings #WR4, T4, T10, T13, T14, T16, NR9, NR11, and CC11, and condition # T1 (traffic counting equipment only).

The project, as proposed, is consistent with the Minimum Performance Standards of the Regional Policy Plan.

Based on a letter from the Bourne town planner dated July 17, 2006, the proposed project is consistent with the Bourne zoning bylaws provided that the project obtains a special permit as required by the Town.

The town of Bourne does not have a certified Local Comprehensive Plan (LCP).

The proposed project is not located within a District of Critical Planning Concern (DCPC).

The Cape Cod Commission hereby approves the application of Lenord G. Cubellis, for the CanalSide Commons project in Bourne, MA, provided following conditions are met:

CONDITIONS

General

G1. This DRI decision is valid for 7 years and local development permits may be issued pursuant hereto for a period of 7 years from the date of the written decision.

G2. Failure to comply with all conditions stated herein, and with all related statutes and other regulatory measures, shall be deemed cause to revoke or modify this decision after notice to the applicant.

G3. The applicant shall obtain all necessary state and local permits for the proposed project.

G4. No development work, as the term "development" is defined in the Act, shall be undertaken until all appeal periods have elapsed or, if such an appeal has been filed, until all judicial proceedings have been completed.

G5. Any development, re-division, or reconfiguration of the locus other than that authorized by this decision, including the 2.0 – acre parcel, the 5.3 – acre parcel which includes portions of Assessor's Map 224, Lot 13.1, Book 13688 Page 241, and Assessor's Map 25, Lot 3, Book 13688 Page 241, the 14.8 – acre parcel, and the 93.1 – acre parcel, all as shown on Sheet C – 15, Open Space Analysis Plan, prepared by Cubellis Associates, Inc., dated June 12, 2006, shall be reviewed as a Development of Regional Impact or as a modification to this DRI decision in accordance with Chapter A, Section 12 of the DRI Enabling Regulations.

G6. The applicant shall provide the Commission with an annual progress report to be submitted on or before the anniversary of the date of this decision. The annual progress report shall describe the status of local development permitting and project construction, including the expected date of commencement of site preparation work. The applicant shall report changes to the annual progress report. The requirement to file annual progress reports shall be terminated upon the receipt of a Final Certificate of Compliance.

G7. The proposed CanalSide Commons project shall be constructed in accordance with the following final plans:

- Development of Regional Impact Alternative Site Plan Submission for CanalSide Commons, revised July 14, 2006, sheets C1 – C15, and A1 – 8
- Construction Phasing Plan, Cubellis Associates, Inc. received June 7, 2006
- CanalSide Commons Phased Parking Plan, Cubellis Associates, Inc., dated July 24, 2006
- Initial and Maintained Light Levels, sheets #L1 and #L2, Cubellis Associates, Inc., drawn by BLS, dated 5/12/06
- Conceptual Improvement Plan, Sandwich Road @ Adams Street, by Vanasse Associates, Inc., dated June 8, 2006 and revised July 10, 2006
- Preliminary Conceptual Improvement Plan (Bypass Road plan), Vanasse Associates, Inc., dated March 21, 2006 and revised March 22, 2006
- Conceptual Building and Pylon Sign Plans, received July 27, 2006

G8. Prior to issuance of a building permit for any phase of construction, the applicant shall submit final plans as approved by local boards for review by Commission staff to determine their consistency with this decision and/or information submitted as part of the DRI review. Any deviation during local review or during construction from the approved plans, including but not limited to changes to the building design, building location, lighting, landscaping or other site work,

shall require approval by the Cape Cod Commission through a modification process, pursuant to Section 12 of the Commission's Enabling Regulations. The applicant shall submit to the Commission any additional information deemed necessary to evaluate any modifications to the approved plans.

G9. Prior to issuance of a building permit for any phase of construction, the applicant shall obtain a Preliminary Certificate of Compliance from the Commission. All conditions of this decision required before issuance of a building permit shall be met prior to issuance of a Preliminary Certificate of Compliance for such phase.

G10. Prior to receiving a permanent or temporary Certificate of Occupancy for Phase 1 of the proposed project, the applicant shall obtain a Partial Certificate of Compliance from the Cape Cod Commission. Prior to receiving a permanent or temporary Certificate of Occupancy for Phase 2 of the proposed project, the applicant shall obtain a Final Certificate of Compliance from the Commission. All conditions of this decision shall be met prior to issuance of a Final Certificate of Compliance.

G11. No new building area within a phase shall be open for business to the public until a Certificate of Compliance is received from the Cape Cod Commission for such phase.

G12. The applicant shall notify Commission staff of the intent to seek a Certificate of Compliance at least sixty (60) days prior to the anticipated date of seeking such Certificate. Such notification shall include a list of key contact(s) for questions that may arise during the Commission's compliance review. Commission staff shall complete an inspection under this condition within seven (7) business days of such notification and inform the applicant in writing of any deficiencies and corrections needed. The applicant understands that the Commission has no obligation to issue a Certificate of Compliance unless all conditions are complied with or secured consistent with this decision. The applicant agrees to allow Cape Cod Commission staff to enter onto the property that is the subject of this decision for the purpose of determining whether the conditions contained in the decision are met.

G13. The applicant shall demonstrate that a copy of this decision has been provided to the general contractor and all tenants (if applicable) prior to the start of construction.

Water Resources

WR1. The stormwater and wastewater systems shall be designed and constructed as shown on sheets C6 – C8, Grading and Drainage and Utility Plans, and Sheet C12, Detail sheet, DRI Alternative Site Plan Submission for CanalSide Commons, revised July 14, 2006.

WR2. CanalSide Commons, LLC, a Massachusetts limited liability company, shall be responsible for the implementation of the stormwater system management plan listed in Drainage Report and Hydrologic Analysis for CanalSide Commons, prepared by Cubellis Associates, Inc., November 4, 2005, revised May 16, 2006.

WR3. The conservation restriction proposed for the eastern portion of the site shall include provisions allowing the activities associated with public water supply development.

Natural Resources/Open Space

NR1. In order to address the significant habitat values found within portions of the proposed open space area due to the presence of rare species habitat, the applicant shall coordinate preparation of a conservation restriction for the 93.1 - acre conservation area with the NHESP, allowing them to review and comment on the document. The conservation restriction shall allow, as appropriate and as recommended by the NHESP, the conservation grantee, and the Commission, for monitoring and management of the conservation restriction area for rare species habitat.

NR2. Prior to issuance of a Preliminary Certificate of Compliance for Phase 1 of the proposed CanalSide Commons project, the applicant shall provide the Cape Cod Commission with a draft conservation restriction of a form and substance satisfactory to the Commission or its designee and consistent with Massachusetts General Laws Chapter 184, § 31 – 33 and accompanying plan which provides that 93.1 acres located to the east and south on the CanalSide Commons site and identified as open space on the plan titled "Open Space Analysis" as prepared by Cubellis Associates, Inc. and dated 3/20/06 shall be preserved as permanent open space. The conservation restriction shall be held by an appropriate conservation entity to be approved by Commission counsel. The restriction and site plan shall be approved by Commission counsel, executed and recorded at the Registry of Deeds or Registry District of the Land Court, and proof of recording shall be provided to the Commission prior to the applicant's request for a Partial Certificate of Compliance for Phase 1 of the proposed project. In order to preserve the significant habitat values of the open space areas protected through this conservation restriction, the land subject to this conservation restriction shall remain undisturbed for conservation and wildlife habitat preservation purposes. Notwithstanding the habitat preservation interests, the conservation restriction shall provide for public access via walking/running trails, and for the possible development of a public water supply contingent upon protection of the rare species habitat interests of the site and the receipt of permit approvals for a public water supply.

NR3. Prior to recording the conservation restriction, the applicant shall install permanent concrete bounds demarcating the conservation restriction area.

NR4. Should the applicant expand the CanalSide Commons project area to include the referenced Simpson parcels located to the west and south of the project site, open space for these parcels shall be provided in an amount required by the 1996 RPP, or 65% of the site area for the southerly parcel, and 50% of the site area for the westerly parcel.

Economic Development

ED1. Prior to the issuance of a Final Certificate of Compliance, the applicant shall provide a report to the Commission detailing the number of Cape Cod contractors, local suppliers, and workers employed during the construction phase of the project. The applicant shall note those businesses that are women or minority owned.

ED2. Within one year from the date of issuance of a Final Certificate of Compliance, the applicant shall provide a report to the Commission detailing the number of new full-time and part-time jobs created, the position titles, wages and benefits to be paid, and the number of minorities, disabled, elderly, unemployed or underemployed persons expected to fill the new positions.

Transportation

T1. Prior to issuance of a Preliminary Certificate of Compliance for Phase 1 of the CanalSide Commons project, the Applicant shall provide to the Commission staff for review and approval (including 25%, 75% and 100% submissions) all necessary plans and permits (including all MassHighway and town of Bourne permits) to implement the following mitigation, in accordance with Transportation Findings T3 and T12.

Sandwich Road/Adams Street	Design and Installation of a traffic signal as outlined in the Conceptual Improvement Plan, Sandwich Road @ Adams Street, by Vanasse Associates dated June 8, 2006 and revised July 10, 2006. The Sandwich Road/Adams Street traffic signal shall incorporate ornamental mast arms and/or ornamental signal heads and related ornamental signal equipment, opticom (or equivalent) emergency access equipment, traffic monitoring devices with remote access connecting to the CCC office, and alternative paving treatment for any crosswalks.
Belmont Circle	Implement the Canal Area Transportation Information System as outlined in the CanalSide Commons DEIR/DRI, dated February 16, 1999, Vol. III, pg. 1-133 & Fig. 1.7-48 by Coler & Colantonio, Inc and Cubellis Associates.
Otis Rotary	Install "Rotary Ahead" warning signs in advance of the rotary on all approaches and upgrade all signs and pavement markings within the rotary and on the rotary approaches to current design standards, as outlined in the plan by Vanasse Associates, Inc titled Preliminary Conceptual Plan dated April 4, 2006. This plan was submitted on April 21, 2006 by Attorney Patrick Butler.

Bourne Circle	Design and Construction of the Bypass Road connecting Route 28 northbound with Sandwich Road eastbound. The Bypass Road construction will include signalization of the existing Upper Cape Technical School driveway. In addition, the Bypass Road conceptual plan includes new signage and pavement marking on the rotary and stanchions on the Bourne Bridge approach to the rotary. These improvements are shown on the Preliminary Conceptual Improvement Plan for the Bypass Road dated March 21, 2006 by Vanasse Associates, Inc. The Sandwich Road/Bypass Road east terminal traffic signal shall incorporate ornamental mast arms and/or ornamental signal heads and related ornamental signal equipment, opticom (or equivalent) emergency access equipment, traffic monitoring devices with remote access connecting to the CCC office, and alternative paving treatment for any crosswalks.
Barlows Landings Road/Shore Road	Modify the northeast corner between Barlow's Landing Road and Shore Road to reduce the radius from 60 feet to 35 feet. Modify crosswalks across Barlow's Landing Road (westbound) and Shore Road (southbound) to match the reduced radius. Relocate the stop sign on the Barlow's Landing approach to reflect the revised crosswalk location.

T2. Prior to the issuance of a Partial Certificate of Compliance for Phase 1 of CanalSide Commons project, the applicant shall implement the required projects in accordance with the mitigation table in Transportation Condition T1. As specified in Findings T6 and T7, implementation of these projects is the sole responsibility of the Applicant. If any other parties (public or private), prior to the Applicant's constructing mitigation at these locations, construct traffic improvements at any of these locations that make the Applicant's proposed mitigation unnecessary or impractical, the Applicant shall pay an amount equivalent to that proposed mitigation cost at those locations to the County of Barnstable/Cape Cod Commission. Such payments in lieu of in-kind traffic mitigation are necessary to comply with MPS 4.1.1.1 and shall be used to support transportation improvements in the town of Bourne.

T3. Prior to issuance of a Partial Certificate of Compliance for Phase 1 of the proposed CanalSide Commons project, the applicant shall pay a total of \$104,500 for roadway mitigation. These funds shall be held in a mitigation account at Barnstable County/Cape Cod Commission and shall be applied to transportation improvements in the Towns of Bourne, Sandwich, Barnstable, and Falmouth (study area towns impacted by this project), as follows:

Sandwich	\$39,400
Barnstable	\$6,100

Falmouth	\$22,600
	Total \$104,500

T4. Prior to issuance of a Partial Certificate of Compliance for Phase 1 of the proposed CanalSide Commons project, the applicant shall implement and maintain the following employee based trip reduction program.

- Assemble information regarding carpooling and its benefits to be distributed to tenants and their employees.
- Designate an area where carpool information will be posted for all employees of the project.
- Implement a guaranteed ride home program (taxi service) for use in the case of an emergency for program participants.
- Designate preferential parking spaces for employees that carpool.
- Provide secure bicycle storage areas to accommodate bicycles for both employees and patrons.
- Work with tenants to provide on-site services to decrease employee midday trip making. The on-site services would include a lunchroom, microwave, refrigerator, and prepared foods.
- Provide an on-site transportation coordinator. The transportation coordinator would be responsible for ensuring that the complete rideshare program, including car/vanpools; accommodating work shifts; promotions; incentives; preferential parking; and guaranteed ride home program, is consistently promoted and provided.
- Provide flexible work hours for employees that car/vanpool.
- Work with tenants to develop employee work hours to match transit schedules for transit riders.
- Implement a transportation fair to be held at least once a year and invite the CCC, the Town of Bourne and other area tenants.
- Distribute to all employees a new employee information packet that will include information about the various travel demand management (TDM) programs that are available and the ways in which employees can participate.
- Provide a quarterly bulletin or newsletter reminding employees about the TDM programs and making the employees aware of any new or modified services.
- Install commuter information centers or bulletin boards at one or more location(s) that would include up-to-date information about the various TDM programs that are available, as well as transit schedules and maps, ride matching forms and promotional fliers.
- Provide bicycle maps indicating the location of bicycle facilities in the area, posted in central locations within the development to encourage bicycle commuting.
- Provide a reference in all promotional materials or link, in the case of a website, to the Cape Cod Commission transportation information center Travel Demand Management services at www.gocapecod.org/tdm. In addition, website based materials and advertising developed for the project would include listing and links to available public transportation services serving the project site.
- Each tenant shall provide daily incentives for any employee who commutes to work using alternative methods that reduce automotive trips such as bicycling, walking, carpooling or transit. These incentives may include free meals through coupons/discount cards for use toward

the purchase of goods and services within the development or at adjacent retailers and entries for weekly raffle for prizes such as movie tickets, free meals and/or goods and services.

- Provide one transit stop within the development.

T5. Prior to issuance of a Partial Certificate of Compliance for Phase 1 of the proposed CanalSide Commons project, the applicant shall donate approximately 90,978 square feet of vacant developable land off Sandwich Road in Bourne, in excess of open space requirements, to a conservation land trust. The parcel of land is identified on Open Space Analysis Plan dated June 12, 2006.

T6. Prior to issuance of a Partial Certificate of Compliance for Phase 1 of the proposed CanalSide Commons project, the Applicant shall provide legal motor vehicle and pedestrian access, in the form of an easement, across the Applicant's property from the Simpson parcel (Assessor's Map 24, Lots 13 and 13.2, Book 13315, Page 84) to the Bypass Road for development of the Simpson parcel. Such an easement shall be at a location mutually agreed upon by the applicant and Simpson and shall be subject to the reasonable terms and conditions to be negotiated by and between the applicant and the owner of the Simpson parcel.

T7. Prior to issuance of a Partial Certificate of Compliance for Phase 1 of the proposed CanalSide Commons project, the Applicant shall clear and maintain a 1200-foot long by 15-foot wide pathway between the Gallo Arena and the proposed entrance driveway on Sandwich Road.

T8. Prior to issuance of a Preliminary Certificate of Compliance for Phase 1 of the proposed CanalSide Commons project, the applicant shall submit a recorded subdivision plan to the Cape Cod Commission in accordance with Massachusetts General Law Chapter 41, Section 81-L for the proposed bypass road as shown on the preliminary conceptual improvement plan dated March 21, 2006 by Vanasse Associates, Inc. The applicant shall dedicate the bypass road as a public way to either the Town of Bourne or MHD as outlined in finding #T15 prior to issuance of a Partial Certificate of Compliance for Phase 1 of the proposed CanalSide Commons project.

T9. Prior to issuance of Preliminary Certificate of Compliance for Phase 1 of the proposed CanalSide Commons project, the applicant shall conduct a study regarding the feasibility and design of sidewalks from the Bourne high school to the project site. The applicant may seek to utilize portions of the funds identified in condition #T3 for actual construction of sidewalks as outlined in the feasibility study.

T10. The applicant shall construct a maximum of 491 parking spaces for the proposed retail uses on the project site in accordance with the CanalSide Commons Phased Parking Plan, Cubellis Associates, Inc. dated July 24, 2006. Areas designated on the Phased Parking Plan for future parking (47 spaces) shall remain as grassed or landscaped areas unless and until a DRI approval is granted for potential apartments over the retail uses.

Solid Waste

SW1. Prior to issuance of a Preliminary Certificate of Compliance for Phase 1 of the proposed CanalSide Commons project, the applicant shall provide to staff a site plan of the proposed 78,500 square foot specialty retail complex and a 6,500 square foot restaurant that details the location of the infrastructure for the recycling of used cardboard, vegetable food wastes, as well as tin cans, glass bottles and plastic containers.

Hazardous Materials/Waste

HAZ1. The applicant shall demonstrate that a copy of this decision has been provided to the general contractor(s) prior to the start of construction.

HAZ2. On-site servicing of construction equipment shall be limited to greasing of fittings and joints during construction of any phase of the project. On-site engine repairs and similar "heavy" maintenance shall be prohibited. On-site storage of fuel and any fueling and refueling activities shall be done on a designated part of the site which is located outside the area designated by 1996 RPP maps as a PPWSA. On-site fueling shall be done, at a minimum, on an impervious surface and with spill containment and response supplies available.

HAZ3. Prior to any development on the site, and prior to issuance of a Preliminary Certificate of Compliance by the Cape Cod Commission for Phase 1 of the proposed project, the applicant shall submit for Commission staff review and approval:

- a. Specifications for and plans showing the location of on-site areas for equipment fueling, overnight storage of construction equipment, and storage areas for any hazardous materials or hazardous waste associated with or generated by construction activities.
- b. Examples of construction bid documents that incorporate hazardous materials and waste minimization and management provisions.

HAZ4. Prior to issuance of a Partial Certificate of Compliance for Phase 1 of the proposed project by the Cape Cod Commission, prior to issuance of a Final Certificate of Compliance, and prior to any Certificates of Use/Occupancy issued by the Town, the applicant shall submit proof that fuels other than liquid petroleum (*i.e.* natural gas) will be used for building heating and emergency power generation. The applicant shall also submit for Commission staff review and approval examples of lease restrictions and tenant education plans to address MPS 4.2.2.1 and 4.2.2.2. for the project's post-construction phase.

Heritage Preservation/Community Character

CC1. The proposed CanalSide Commons buildings shall be constructed consistent with approved floor plans, roof plans and elevations drawings dated 9-29-05 (Buildings A through F) and 9-28-05 (Kiosk and Building G).

CC2. Any proposed changes to the design of the CanalSide Commons buildings shall be submitted to Commission staff for review to determine if they are consistent with RPP Performance Standards. Any changes to building design shall maintain or increase the amount of building variation reflected in the footprints and elevations of the approved plans.

CC3. All proposed exterior building materials that are not traditional materials shall be submitted to Commission Staff to review for consistency with RPP Performance Standards.

CC4. Existing vegetation outside the limit of work shall be protected during construction with flagging or construction fencing. Existing wooded buffers on the project site shall remain in their natural state without alteration over the life of the project.

CC5. Slopes adjacent to the bypass road, except for areas noted otherwise, shall be revegetated with the New England Erosion control/Restoration mix from New England Wetland Plants, or a similar mix of erosion control species and warm season grasses. In addition, these areas shall be planted with native tree saplings and bare root or 1-gallon shrubs at a rate of 1 per 500 sq ft. The trees and shrubs shall be planted in groupings placed throughout the restoration area in such a fashion that they may provide visual interest and some habitat cover when mature. At a minimum, 40% of the required plantings shall consist of the following: *Juniperus virginiana* (Eastern Red Cedar), *Quercus rubra* (Red Oak), or *Pinus strobus* (White Pine); at a minimum, 25% of the required plantings shall be *Myrica pensylvanica* (Bayberry), *Aronia arbutifolia* (Red Chokeberry), *Prunus maritima* (Beach Plum), *Acer ginnala* (Amur Maple), *Viburnum trilobum* (American Cranberry). The remaining 35% of the plantings shall be some combination of these specified species.

CC6. Prior to issuance of a Preliminary Certificate of Compliance for Phase 1 of the proposed project, the applicant shall submit a draft maintenance contract for all proposed landscaped areas based upon guidelines provided by Commission staff. Prior to issuance of a Partial Certificate of Compliance for Phase 1 of the proposed project from the Commission and prior to issuance of a Final Certificate of Compliance, the applicant shall provide a fully executed landscape maintenance contract for 3 full growing seasons. A growing season is defined as the period between March 15th and October 31st.

CC7. Plant materials specified by this decision may be substituted with prior written approval of Commission staff.

CC8. If all required site work and/or landscape improvements associated with Phase 1 of the proposed project are not complete at the time a Partial Certificate of Compliance is sought from the Commission, any work that is incomplete shall be subject to an escrow agreement of form and content satisfactory to Commission counsel. The amount of the escrow agreement shall equal 150% of the cost of that portion of the incomplete work, including labor and materials, with the amount approved by Commission staff. The escrow agreement may allow for partial release of escrow funds upon partial completion of work. The check shall be payable to Barnstable County with the work approved by Commission staff prior to release of the escrow funds. Unexpended escrow funds shall be returned to the applicant, with interest, upon completion of the required work. All site


work and/or landscape improvements shall be completed prior to issuance of a Final Certificate of Compliance from the Commission.

CC9. Prior to issuance of a Preliminary Certificate of Compliance for Phase 1 of the proposed project, the applicant shall submit final plans for any proposed pylon signs and their location on the site plan for staff approval to ensure their consistency with MPS 6.2.8 and the concept sign plan dated July 27, 2006. Such plans shall include proposed materials, method of illumination and dimensions.

CC10. All exterior lighting for the project shall be installed consistent with the proposed Landscape & Lighting Plan, sheet #C13, prepared by Cubellis Associates, Inc. dated 3/20/06, revised 6/12/06. Exterior lighting for the project shall also be consistent with the design described in finding CC12. Should conditions arise during project construction that require adjustments to site exterior lighting fixtures, including substitutions of fixture heads, the applicant shall obtain written approval from Commission staff prior to their installation and/or use consistent with Commission's procedures for modifications in the *Enabling Regulations*. Modifications to the project's exterior lighting design made during construction that are in accordance with the Commission-approved lighting information shall be considered as Minor Modifications #1 and may be approved by Commission staff.

CC11. Prior to issuance of a Partial Certificate of Compliance by the Commission for Phase 1 of the proposed project, prior to issuance of a Final Certificate of Compliance, and prior to issuance of any Certificate of Use and Occupancy at the local level, the applicant shall clarify whether any on-building, recessed fixtures, landscape accent, bollards or other non-pole mounted fixtures are to be used as part of the project. Prior to issuance of the Final Certificate of Compliance, Commission staff shall conduct a site visit to verify conformance of the project's final exterior lighting design with MPS 6.2.7, Technical Bulletin 95-001, finding #CC12 and condition #CC10 of this decision. The applicant shall submit as needed information about the project's final exterior lighting design consistent with Section 3.0 of Technical Bulletin 95-001 so that the site visit can be based on the most current information. No Final Certificate shall be issued until Commission staff issues a written assessment of the project's final exterior lighting design indicating that it is consistent with MPS 6.2.7, Technical Bulletin 95-001 and condition #CC10.

The Commission hereby approves with conditions the application of Lenord G. Cubellis for the proposed CanalSide Commons project in Bourne, MA as a Development of Regional Impact pursuant to Sections 12 and 13 of the Act, c. 716 of the Acts of 1989, as amended.
