The Cape Cod Commission will conduct a public hearing on **Thursday, July 6, 2017 at 3:00 p.m. in the First District Courthouse, Assembly of Delegates Chambers, 3195 Main Street (Route 6A), Barnstable, MA.** The following Development of Regional Impact (DRI) Scoping application was submitted to the Cape Cod Commission under Sections 3 and 5 of the Cape Cod Commission's *Enabling Regulations Governing Review of Developments of Regional Impact*. The Commission will consider and potentially vote on a draft written DRI Scoping Decision for the project which, if adopted by the Commission, would allow the applicant to proceed with local permitting for the project, subject to the DRI Scoping Decision, without the requirement for any further DRI review. This notice is being published as required by Section 5 of the *Cape Cod Commission Act*.
