The Cape Cod Commission will conduct a public hearing on **Thursday, December 14, 2017 at 3:00 p.m. in the First District Courthouse, Assembly of Delegates Chambers, 3195 Main Street, Barnstable, MA.** The following project was referred to the Cape Cod Commission as a Discretionary Referral by the Town of Eastham pursuant to Section 3 of the Cape Cod Commission's *Enabling Regulations Governing Review of Developments of Regional Impact*. At its meeting on July 6, 2017, the Commission voted to accept the Discretionary Referral from the Town of Eastham for Development of Regional Impact (DRI) review of the project in the Regional Policy Plan issue areas of land use, economic development, water resources, transportation and heritage preservation/community character. The Commission opened the DRI public hearing period on the project September 1, 2017 and closed the period November 29, 2017. No DRI application has been submitted for the project. At this hearing the Commission will move to procedurally deny the project (without prejudice). This notice is being published pursuant to Section 5 of the *Cape Cod Commission Act*.
