Hi,

I want to thank Dr. Scherzo for taking the time to send in a comment letter on the Harwich CWMP. I also want to emphasize the Harwich CWMP clearly addresses phosphorus issues in the freshwater ponds in town. Perhaps in the limited time for presentation at the CCC Public Hearing that didn't come across. However, the town recently funded the full water quality analysis of Hinckleys Pond (report posted on town website) and has several other ponds identified for similar analysis going forward. The funding for recommended restoration of the ponds is also noted in the implementation phasing plan. The Six Ponds area is recommended for sewerage specifically to address the dense development up gradient of those ponds to remove the phosphorus from those septic systems. So phosphorus has not been ignored in any way as part of this comprehensive plan for the reasons noted in the comment letter.
