Cape Cod Metropolitan Planning Organization (MPO) votes to release a TIP Amendment

The Cape Cod Transportation Improvement Program (TIP) for Federal Fiscal Years (FFY) 2012-2015, originally endorsed on August 22, 2011, was brought back to the MPO on Monday, January 23, 2012, for project cost estimate updates and additions. The Cape Cod MPO released a public **Draft TIP Amendment for FFY 2012-2015** for public review and comment. The CCJTC will consider the *Draft TIP Amendment* on Friday, February 10, 2012. Changes included in the TIP Amendment to the original TIP are summarized below:

BRIDGES Dennis bridges combined into one project; Chatham Bridge moved to 2013 603892 Dennis Bridge Upper County Road is now combined with Rte. 28/Main St. Bridge 605291 Dennis BRs: Upper County Rd. & Rte. 28/Main St. \$ 10,964,561 Combination of the two bridges into one contract may facilitate improved coordination of the construction.
