The Cape Cod Commission will hold a virtual public hearing Thursday December 17, 2020, 3 PM, to consider the following Development of Regional Impact (DRI) Exemption request submitted pursuant to Section 12(k) of the Cape Cod Commission Act, as amended. At this hearing, the Commission may decide and vote on the request.

**Project:** Sandwich Water District Approval Not Required (ANR) Plan (CCC File # EX-20061)  
**Project Applicant:** Sandwich Water District  
**Project Location:** 295 Service Road, Sandwich, MA 02537 (Assessors Map 33 Parcel 49)  
**Project Description:** Proposed division of land to create a new .33+/- acre parcel which is proposed to be conveyed to the Sandwich Water District for public water supply purposes.
